Advance notice of the public meeting was sent to Nebraska news media by means of a news release forwarded from the Commission office with Agenda posted in the NET Lobby and on the State and NET web sites. LB 898 (related to Open Meetings Act) is also posted in the NET Board Room on 1st floor.

Chair Clay Smith called meeting #447 to order at 9:32 a.m.

Following the call of the roll, it was determined that a duly constituted quorum of Commissioners to be present.

The Chair called for public comment. There was none.

The Chair next requested approval of the minutes of meeting #446 as held on June 25, 2015. Roll call vote to approve minutes #446 was recorded as follows: voting aye: Commissioners Baack, Bird, Carpenter, Gaswick, Hadley, Kircher, Shoemaker, Smith, Starman and Troutman; absent: Commissioner Ohles. Motion approved.

AGM-Administration & Finance Randy Hansen presented the 4th quarter budget report for period ending June 30, 2015 for both the Television and Radio Divisions. The Finance Committee met prior to the meeting to review the report in greater detail. It was moved by Commissioner Shoemaker and seconded by Commissioner Bird to approve the 4th quarter budget reports as presented and attached to the minutes. Roll call vote was recorded as follows: voting aye: Commissioners Baack, Bird, Carpenter, Gaswick, Hadley, Kircher, Shoemaker, Smith, Starman and Troutman. Absent: Commissioner Ohles. Motion approved.

Commissioner Ohles joined the meeting in progress at 9:45 a.m.

AGM-Administration & Finance Hansen reviewed the FY 2016 Television Capital Equipment List. Within the television operational budget is a line item for \$800,000. This line item is for

capital purchases of systems required to either maintain or enhance the capabilities of the television infrastructure and equipment. The list is decided on by a committee consisting of the Assistant Director of Engineering (Transmissions/Network Operations, Information Technology and Information Systems), a representative from the TV Production Department, Director of Media Services, Assistant General Manager of Operations and the Assistant General Manager for Technology. It is based on agreed upon prioritized needs in the system. This year the priority for item selection is as follows: 1) items that need immediate replacement to keep the current level of service; 2) items that affect the enterprise as a whole; 3) items that will have a long term impact on operations within a specific Department; and, 4) all other items.

AGM-Administration & Finance Hansen reviewed the FY 2016 Radio Capital Equipment List. Within the radio operational budget is a line item for \$52,000. This line item is for capital purchase of systems required to either maintain or enhance the capabilities of the Radio infrastructure and equipment. The list is decided on by a committee consisting of the Assistant Directors of Engineering (Transmissions/Network Operations, Information Technology and Information Systems), several representatives from the Radio Department, Assistant General Manager of Operations and the Assistant General Manager for Technology. It is based on agreed upon prioritized needs in the system. This year the priority for item selection is as follows: 1) items that need immediate replacement to keep the current level of service; 2) items that affect the enterprise as a whole; 3) items that will have a long term impact on operations within a specific department; and, 4) all other items.

It was moved by Commissioner Starman and seconded by Commissioner Bird to approve the FY 2016 Television and Radio capital equipment lists as presented. Roll call vote was recorded as follows: voting aye: Commissioners Baack, Bird, Carpenter, Gaswick, Hadley, Kircher, Ohles, Shoemaker, Smith, Starman and Troutman. Motion approved.

Secretary Leonard presented an update on the KTNE Tower at Alliance. The Insurance Company is accepting responsibility for a majority of the expenses. Bids have been received to replace the antenna. The technical specifications recommend that a tower structural analysis is necessary before awarding the bid. NET has contacted the tower manufacturer and requested an expedited Structural Analysis.

Commissioner Kircher left the meeting at 9:55 a.m.

The Secretary also gave an update on the KYNE tower removal/relocation on the property of University of Nebraska at Omaha. A meeting was held with KETV and their engineering staff to address the spectrum auction uncertainty and the effects to the previous planning efforts. It was suggested that a small building be built to separate NET from the current building as originally planned. Cancellation letters have been sent to current cellular providers that they will need to relocate their antennas from the current UNO tower.

Secretary Leonard reviewed the situation that has resulted with HBO licensing Sesame Street. PBS will now broadcast programs nine months after viewing on HBO.

AGM-Education Gary Targoff gave an update on Interactive and Education Media projects including the Ready to Learn (RTL) events that has reached 68 community based organization across the State. NET, in collaboration with the Nebraska Association of School Boards, Nebraska Children and Families Foundation, and Nebraska Loves Public Schools, will visit eight communities starting with Chadron on September 9.

General Manager Leonard reviewed activities in NET Operations/Transmission area on behalf of Ling Sun, AGM-Engineering. The KHNE Tower in Hastings is currently being upgraded to

accommodate NRIN Microwave Antenna. This project is being managed by the Nebraska Emergency Management Agency (NEMA) and Office of the Chief Information Office (OCIO).

The Chairman called for New Business. General Manager Leonard indicated that a formal invitation will be extended on behalf of NETC to Senators on the Appropriations Committee. They will be invited to come to NET for a tour and informational meeting.

There was a question as to why Backyard Farmer was moved to Tuesday night. Some viewers have indicated their preference to be Thursday night as in the past.

The following dates for 2016 were reviewed. February 16 (Videoconference Meeting); June 23—NET; August 25 or September 1; and December 1 or December 8. Commissioners will be polled to determine best meeting dates for the August/September meeting and the December meeting.

Being no further business, Chairman Smith requested that Meeting #447 be adjourned at 10:35 am.

Response to FCC Spectrum Auction

EXPLANATION:

As part of the 2012 Middle Class Tax Relief Act Congress directed the Federal Communications Commission (FCC) to free up UHF broadcast spectrum for re-sale to wireless providers in an auction to be conducted by the FCC. The FCC has spent the last two years preparing for this unprecedented auction. Television station license holders such as the Nebraska Educational Telecommunications Commission have until January 12, 2016 to indicate to the FCC whether or not they intend to participate in the voluntary spectrum auction. Licensees may choose to: 1) go off the air (or channel share); 2) move from a UHF to a high VHF or low VHF channel; 3) move from a high VHF to a low VHF channel; or 4) choose not to participate in the auction.

Following the reverse and forward auctions, TV stations that remain on air will be subject to a "repacking" in which they may be assigned new broadcast channels. The FCC will compensate TV stations who are involuntarily moved to new channels for a portion of the costs of repacking, although no details regarding compensation have been released.

Even stations that elect not to participate in the auction need to pay attention to the auction procedures, because certain of the FCC's anti-collusion rules will apply during the auction even to broadcasters that do not plan to sell their frequencies.

NET Television has almost universal over-the-air coverage throughout Nebraska through its nine full-powered transmitters and 15 low-powered translators. Eight of the transmitters are licensed to the State of Nebraska with oversight authority rested in the Nebraska Educational Telecommunications Commission. The ninth transmitter, KUON Lincoln, is licensed to the Board of Regents, with oversight from the University of Nebraska-Lincoln through the Senior Vice Chancellor for Academic Affairs. A long-time Memorandum of Understanding exists between the Board and the NET Commission regarding the operations of the statewide network.

Early feedback (summer 2014) from NET's broadcast attorneys in Washington advised that there likely would be no market for any NET channels due to our remote plains location—the greatest demand for spectrum is expected to be concentrated around highly populated areas like New York, Los Angeles,, Chicago, etc. Thus, when the FCC listed its "opening bid" prices for all TV stations in the country on October 16, 2015, management was surprised to see opening bid amounts on seven of NET's nine television

transmitters, with the highest amount listed as \$110,782,800 for relinquishment of KYNE Omaha. KUON Lincoln was second highest at \$93,391,380

To fully evaluate the possibility of revenue from the sale of any NET licensed spectrum NET commissioned a valuation study from the Public Media Company, a respected public media consulting firm that deals in valuations, mergers and acquisitions. Management requested an evaluation of the three NET stations that had the highest opening bids on the recently released FCC document. This third party analysis was competed and forwarded to NET on November 12. There was extensive detail to the report, including an explanation of its methodology, but the cover letter summarized the findings quite succinctly:

"The analysis indicates that KYNE, KUON, and KXNE are not expected to be in the mix of stations likely to be purchased by the FCC."

NET is a cherished resource in Nebraska, serving as one of the few connecting institutions that link all citizens across this vast state. Over half the state watches NET in any given week, with High School Championship sports broadcasts often reaching blockbuster ratings status. NET provides more than 50 hours of weekly non-commercial educational content directed towards children ages 2-8. NET also distributes Amber Alerts across the state and vital emergency notifications. With the implementation of the ATSC 3.0 broadcast standard approaching, the opportunities for expanded service in education, public safety, emergency communication, and data distribution all offer powerful reasons to keep and maintain our full complement of broadcast channels. The concept of universal service represents a fifty-two year old commitment to provide free over-the-air public television services for all citizens of the state.

The NETC Spectrum Working Committee (Commissioners Smith, Bird, Shoemaker and Troutman) met on November 20, 2015 to review options and provide a recommendation to the full NETC.

COMMISSION ACTION:

The NETC Spectrum Working Committee unanimously recommends that the NETC vote to not participate in the FCC auction for any and all of the licenses held by the NETC.

NETC Engineering Report

PBS Project:

PBS Diversity, Disaster Recovery and Maintenance Site (DDMS) - Diversity part is fully operational and is used as needed by PBS. PBS is seeking bringing PBS program services (World, Create, V-me and First Nation Experiences) from its program service provider to DDMS via terrestrial paths. These services currently are being delivered to DDMS via satellite.

NET Terrestrial Circuit:

- (a) NebraskaLink has completed the installation of a diversity path between NET and the Office of the Chief Information Officer (OCIO), this is to eliminate a single point of failure. We are waiting for the OCIO to activate the circuit and complete the auto switch over function.
- (b) The Type of Service (ToS) / Quality of Service (QoS) designator we initiated with OCIO to improve reliability of the content stream is working well. Last month we had no outages on the terrestrial circuit

KTNE DTV Antenna:

Electronic Research Inc. (ERI) of Chandler, IN was issued a State Purchase Order for the replacement antenna at KTNE. Proposed completion date for manufacturing the antenna is January 28, 2016.

The State Purchasing Bureau (SPB) has posted a Request for Proposal (RFP) for the installation of the antenna.

. KTNE on Dish Network in the Scottsbluff area:

The OCIO has installed a terrestrial circuit to Dish Network in Cheyenne, WY that will provide NET service to the Scottsbluff area. The air date is November 19 Channel 13 Local into Local

KYNE Relocation:

Minor change in licensed facilities for call sign KYNE-TV was filed with FCC on Nov. 12 2015

Capital Equipment Purchase:

- (a) Six (6) replacement ASI to 310 Converters have been received and installed at KUON, KHNE, KLNE, KTNE, KXNE and KYNE. These units replace 12 year old Motorola TMX 2010
- (b) Two (2) replacement IP/8VSB to ASI Converts have been purchased and installed at KHNE and KPNE. These units replace 8 year old converters

- (c) Digital Exciters for KHNE FM and KLNE FM have been ordered with installation date scheduled for December 7 and 8. These units will replace 12 year old units
- (d) New Air Conditioners are installed at KUON and KTNE with the Invitation to Bid (ITB) at State Purchasing (SPB) for 20 ton unit at KRNE
- (e) Completed acquiring and installation of a redundant TV PSIP Guide Builder. PSIP defines TV virtual channels as well as provides electronic program guides to viewers
- (f) Storage purchasing is in progress to expend NET Enterprise storage system

Decatur K34IB Translator:

The Decatur (K34IB) Translator building owners have notified NET of their decision to remove and not replace the structure that houses NET equipment. An outdoor enclosure have been ordered and received to house NET equipment and maintain coverage.

Imagine Automation Project:

- (a) Completed integration of Motion 4 with NET Media Management System.
- (b) Completed the Isilon (EMC) storage upgrade and all files have been transferred without interruption.

COMMUNITY ENGAGEMENT

State of Education in Nebraska (SOEN)

Education Reform in Nebraska aired on September 20. This NET studio production engaged Nebraska experts in a discussion on different aspects of school reform from charter schools to tax vouchers. Panelists included: Dr. Matt Blomstedt, Nebraska Commissioner of Education; Clarice Jackson, Executive Director, Voice Advocacy Center; Chris Proulx, President, Omaha Education Association; and Jim Vokal, CEO, Platte Institute.

Homeless Students (working title) is tentatively planned for February broadcast. A panel of local experts will discuss the increasing number of students who are without a permanent home and the challenges of reaching and educating students who are homeless. In addition to the broadcast, supplemental content such as NET News stories and a tie to the ITVS national production of "The Homestretch" is being considered.

Community Engagement Tour – NET completed its Community Engagement Tour on November 10. Working with school superintendents in seven diverse communities, over 600 citizens participated in day long discussions starting with an Early Childhood Education workshop conducted by NET Education Specialist Emily Nash, and ending with community wide strategy sessions facilitated by the Nebraska Association of School Boards' Marcia Herring.

Discussions acknowledged the symbiotic relationship between a healthy, thriving community and a strong education system.

Communities involved in the first **SOEN Community Engagement Tour** included: Chadron, Kimball, Schuyler, O'Neill, Valentine, Auburn and Pender.

NET's intent in bringing together this collaboration is to develop on-line multi-media resources to provide a shared experience aimed at community-identified goals, strategies and solutions to move the state's rural communities and school districts forward to meet the challenges of the 21st

century. In addition, material gathered throughout the tour will be used as focus areas for future State of Education in Nebraska television broadcasts.

Indie Lens Pop-Up (formerly known as Coffee and Conversation)

A repeat screening of *Autism in Love* is scheduled for December 13 at the Sheldon Museum of Art. *Autism in Love* is a documentary about four adults at different places on the autism spectrum who open up their personal lives as they navigate dating and romantic relationships. Eye-opening, first-person portrayals show that despite many challenges faced by those with autism, love can find a way.
